**1. Constitute Meeting:** The Group Convenor welcomed everyone to the meeting.

**2. Apologies:** Interim Minister the Rev. Dr. John Oswald.

**3. Matters Outstanding:**

- Replacement light fitting saucer - no further report from Mr Albie Sinclair.
- Electrical System - No evidence of overloading.
- Heaters in Church Hall – The heaters have been moved out slightly from the wall and appear to be working satisfactorily. The high level heaters should be reinstated despite the fact that they do not look good.

**4. Financial situation:**

- All the allocated funds drawn down from the Consolidated Fabric Funds have been expended.
- Mrs Frances Philip agreed to consult with the Finance Convenor regarding funds donated.

**5. Finishing Touches:**

- Blinds, curtains and cushions for the benches in the hall have been completed; blinds for the kitchen and toilet to follow. Many thanks to Mrs Frances Philip and her team.
- The new hall carpet has been fitted – with a change of colour to red, which all agreed is looking very good. Many thanks to Mr Alfred Marshall.
- The safety rail at the rear window in the Church Hall has still to be fitted. The Secretary agreed to approach blacksmith Mr Sandy Andrews.
- Three new tables have been purchased.
- New chairs were chosen – 25 coloured grey. Some members of the congregation are willing to contribute towards the cost of a chair for the Church Hall; an announcement will be made in due course.
- Redecoration of the Vestry and corridor has been undertaken by a work party. Many thanks to all members of the work party.

**6. Official Opening / Open Day:** It was agreed to arrange the formal opening and also an open day for community groups and others who may wish to hire the hall. It was agreed that this should wait until the new chairs are in place. The provisional date of Sunday 16<sup>th</sup> January 2011 was cancelled.

**7. End of Working Group:** This meeting indicated closure of the Working group. Thanks to all who have contributed to this project – especially the Convenor and the Secretary for their guidance throughout.
